Attorney Stuart I. Garson chosen as Ohio Super Lawyer® 2006

Attorney Stuart I. Garson, Founder and Managing Partner of Garson & Associates Co., L.P.A., has been named by *Law & Politics* magazine as an Ohio Super Lawyer® 2006. Ohio Super Lawyers are Ohio attorneys who have attained a high degree of peer recognition and professional achievement. Mr. Garson is a graduate of Cleveland-Marshall School of Law and has practiced law for 29 years. Stuart's practice focuses on Workers' Compensation Personal Injury and Commercial litigation. Mr. Garson currently serves as a director or trustee of numerous organizations including the Executive Committee of the Ohio Academy of Trial Lawyers Workers' Compensation Section, the Cleveland Jewish News, the Cleveland Area Workers' Rights Board, the Moreland Hills Planning Commission, and is a founder of Civic League of Ohioans United Together (Ohio CLOUT). Ohio Super Lawyers are selected through a four-step process. First, *Law & Politics* surveys 35,000 active lawyers in Ohio who have practiced for at least five years. The ballot asks the lawyers to nominate the best attorneys they have personally observed in action. Then, *Law & Politics* conducts interviews and independent research. An attorney-led research panel reviews the credentials of potential candidates and assigns points based on a set of defined evaluation criteria, confirms that the nominees are properly licensed, in good standing with the state licensing agency, and have no history of disciplinary action. Finally, candidates are divided by firm size and geographic location and the top lawyers in each group are then selected as Ohio Super Lawyers.
