An attorney-led research panel reviews the credentials of potential candidates and assigns points based on a set of defined evaluation criteria, confirms that the nominees are properly licensed, in good standing with the state licensing agency, and have no history of disciplinary action. Finally, candidates are divided by firm size and the top lawyers in each group are then selected as Ohio Super Lawyers.
